**COMPLAINT**

**COMES NOW** the Plaintiff, PATRICIA WILKINSON, by and through her undersigned attorney, and sues the Defendant, WALT DISNEY PARKS AND RESORTS U.S., INC. formerly Walt Disney World Hospitality & Recreation Corporation and for this, her Complaint, and alleges:

1. That this is an action for damages which exceeds the amount of FIFTEEN THOUSAND (\$15,000) DOLLARS.
2. That at all times material to this cause, the Defendant, WALT DISNEY PARKS AND RESORTS U.S., INC. was a Florida corporation authorized to do, and doing business in the State of Florida and its predecessor Walt Disney World Hospitality & Recreation Corporation at the time of the injury.
3. On June 6, 2011, the Plaintiff, PATRICIA WILKINSON, was legally upon said premises as a member of the general public who was expressly or impliedly invited upon said premises for the benefit of the Defendant, WALT DISNEY PARKS AND RESORTS U.S., INC., formerly Walt Disney World Hospitality & Recreation Corporation.
4. At said time and place, Defendant, WALT DISNEY PARKS AND RESORTS U.S., INC, had a duty to exercise reasonable care for the safety of patrons and guests on the premises known as ALL STAR MOVIE RESORT, which was owned and operated by WALT DISNEY PARKS AND RESORTS U.S., INC.
5. At said time and place, Defendant, WALT DISNEY PARKS AND RESORTS U.S., INC. formerly Walt Disney World Hospitality & Recreation Corporation by and through their agent, servants and/or employees acting within the scope and course of such agency, service or employment, carelessly and negligently operated or maintained said premises, to wit:

- A. The light designated for the area was not fully functioning and as a result PATRICIA WILKINSON, fell on or about June 6, 2011 at ALL STAR MOVIE RESORT.
6. As a result of the foregoing negligence, the Plaintiff, PATRICIA WILKINSON, was injured in and about her body and extremities, suffered pain therefrom, incurred medical treatment of such injuries, and suffered physical handicap, disability, impairment, disfigurement, aggravation of a pre-existing condition, mental anguish, lost wages and future lost wages, and the loss of capacity for the enjoyment of life. Plaintiff, PATRICIA WILKINSON, will continue to suffer the losses in the future.

**WHEREFORE**, the Plaintiff, PATRICIA WILKINSON, sues the Defendant, WALT DISNEY PARKS AND RESORTS U.S., INC. for damages and seeks a sum in the excess of Fifteen Thousand Dollars (\$15,000.00), exclusive of interest and costs and demands a trial by jury of all issues triable as of right by a jury.
